RE: Dollar Bank Deduction Changes and Benefit Changes

This is a Summary of Material Modification describing changes to your health plan adopted by the Board of Trustees. Please be sure that you and your family read it carefully and keep this document with your Summary Plan Description Booklet.

Eligibility Provisions

The Trust is primarily funded with contributions required under collective bargaining agreements between the IUOE 302 and 612 and signatory employers in Washington and Alaska. When those collective bargaining rates change, monthly amounts required for continued eligibility in the health plan also change.

The following changes have been made to the eligibility provisions: Initial Eligibility

The minimum contribution required to establish Initial <u>Dollar Bank</u> eligibility for <u>Hourly employees</u> will change as follows with **June 2022 hours for August 2022 coverage**:

- from \$1,616.00 to \$1,724 in Washington, and
- from \$1,991.00 to \$2,115 in Alaska

(Contribution amount must be accumulated within a consecutive three-month period).

Continued Coverage

The monthly dollar bank deduction for coverage will change as follows for Bargained <u>Hourly employees</u> whose employers remit contributions for ALL hours worked, with **June 2022 hours for August 2022 coverage**:

- from \$1,077.00 to \$1,149.00 per month in Washington
- from \$1,327.00 to \$1,410.00 per month in Alaska

The monthly dollar bank deduction for coverage will change as follows for <u>Associate</u> and Bargained <u>Flat</u> <u>Rate employees</u> with **July 2022 hours for September 2022 coverage:**

- from \$1,437.00 to \$1,514.00 per month for Washington
- from \$1,687.00 to \$1,773.00 per month for Alaska

Any participant covered by a collective bargaining agreement that has an hourly contribution which is not at least equivalent to the AGC Master Labor Agreement and/or whose employer remits contributions on less than all of participants' hours worked in a month, will be charged the higher Bargained Flat Rate deduction factor, for a month of coverage.

Dollar Bank Maximum

Effective **June 2022 work hours for August 2022 coverage**, the maximum dollar amount that can accumulate in an <u>Hourly employee</u>'s dollar bank is:

- \$9,192 in Washington, and
- \$11,280 in Alaska

Dental Personal Protective Equipment (PPE)

The Board of Trustees of the Locals 302 and 612 IUOE Construction Industry Health and Security Fund have acted to extend the dental PPE coverage until the expiration of the COVID-19 National Emergency. Appropriately billed charges by a licensed dental office for dental PPE will be covered up to \$20 per visit.

Bone Anchored Hearing Aids Benefit

Effective **January 1, 2022**, the Trust will cover medically necessary Bone Anchored Hearing Aids (BAHA) when the patient is 5 years old or older and the following criteria is present:

- Any inner or outer ear conditions that prevent use of a conventional air-conductive hearing aid such as:
 - congenital or surgically induced malformations of the external ear canal or middle ear,
 or
 - chronic external otitis or otitis media, or
 - tumors of the external canal and/or tympanic cavity, or
 - dermatitis of the external canal
- Audiologic test results (hearing test) showing a level of hearing loss requiring BAHA
